9.2 Mr Ray Najar - Coorong Project update

Mr Najar provided an update on the Department for Environment and Water: Project Coorong that he has been involved with, they have completed community consultation and after analyzing the

feedback have shortlisted five infrastructure options for a detailed feasibility assessment investigation:

- 1. Permanent connection between the Coorong South Lagoon and Southern Ocean, including temporary pumping from the Coorong South Lagoon to the Southern Ocean (Salinity reset)
- 2. Coorong Lagoon dredging to improve connectivity
- 3. Further augmentation of South East Flows to the Coorong (SEFA)
- 4. Coorong Lake Albert connector
- 5. Additional automated barrage gates

Options 2,3 and 4 are the most feasible.

This project currently has \$70 million in allocated funding.
