#### ANSWER

Mark Lamb provided this is a real challenge increasing demand on water in the Basin e.g. demands from almond growers. Discussions with MDBA have occurred however it has been determined that it is not the role of the MDBA job to tell farmers what to plant. Mark does not agree with this and believes we have a role to play to educate people about the future and water availability.

#### COMMENTS

Melissa Rebbeck provided that Minister Tanya Plibersek has announced an agreement to develop policy on circular economy. She has also announced the pathway to achieve the 450GL. Pathway is to buy back water. This has occurred in part because of the advocacy of Region 6 and Mark Lamb.
