6. REPORTS

6.1 Chief Executive Officer

(Attachment 1)

- In discussion with CEO of MDBA renewed MOU with MDA and MDBA. Originally established Dec 2014. 5 year MOU. Been a shift in set of roles at MDBA over the past couple of years. First final draft is now ready to be presented to boards for comment. Looks at how to engage better and engaging local government better. Emma mentioned the Basin Community Leadership Program. Under the funding program, 15 eligible communities were identified for funding. MBA approached the department as to why the communities were very southern communities. Funding application (ask JC for more detail) was submitted on Saturday 9 March for consideration for \$500k.
- On Wednesday Emma will be attending a meeting with regulator for feedback

Any feedback regarding operations? Jamie advised not at this stage. Peter advised none that he had heard of in his Shire either.

- Thursday heading to Toowoomba and Dalby to address 10 regional mayors for SE Queensland. Possible representation from the northern region.
 Region 12 include 7 members of those 10 Emma will be meeting with.
- Connecting Catchments and communities forum
- Jamie asked a question regarding the application, with the federal election looming, will that affect the assessment of the application. Emma advised she did not think Caretaker Mode would affect the processing of the application and anticipates it will continue to be processed as usual.
- Task after strategic planning weekend was to obtain funding for a 4 year business case – more likely to be impacted by the federal election and caretaker mode.

6.2 Chairman's report

- Travelled to Strategic Planning workshop with Andrew Johns. Gave rundown on theme of the weekend including succession planning and acquiring new members.
- Invitation for region chairs to sit in on region 7's meeting. No attendance.
 Emma will mention at the next board meeting and encourage chairs to attend as guests at each other's meetings to understand other regional issues.

7. GENERAL BUSINESS

- 7.2 National Conference Registrations not open yet. Website should be live next week.
- 7.3 Jamie The sale of water to the Mining Industry. Price the local mines have recently paid for water at a recent open Auction has local farmers angry as they cannot compete. Emma there is a case to be made regarding the market fluctuation and the impact on the communities. Other side of the argument is should local farmers supplement their income by selling their water. Jamie suggested perhaps an internal debate regarding putting a cap on the rate. John Clements suggested a working

group to get these sorts of issued sorted out. Jamie suggested an agenda item to discuss further.

There is a disconnect between departments regarding the management of the water resource. Annabelle agreed.

Jamie – commented on the effect of the drought on the Gunnedah Region. 1% increase in job loss which relates back to the agriculture and construction industry. It is going further than the farm gate and is more wide spread.

Emma – What are councils doing to prepare for a community response to a continuing drought?

Jamie – The only thing that will help is drought breaking rain. Local council is restricted in what they can do. There are hardship policies in place. His understanding is that there will be a shift once rain comes, to assist farmers to get back on track.

Peter – Council meeting discussed at a recent meeting, for Region 11 to hold BROC meeting in conjunction with MDA meetings. Emma will work with both John and Alex to map out meeting calendars to incorporate other regional meetings

Annabelle Guest and Sally Dickinson joined the meeting at 12.04pm

- **8.3** Namoi Unlimited Joint Organisation


Mayor Jamie Chaffey, who is the Chair of Namoi Unlimited, gave an address regarding the main project for 2019/2020 – Water for the future studies. Consultant is on board to do an audit and analysis for the 5 Shires and is currently underway. Once completed, the organization will be looking at programs that will take the 5 Councils over the next 3-4 years. These could possibly include upgrade utilities supplier, look at the amount of restricted/unrestricted ground water in the 5 areas, utilization and then growth. Hoping to get a list of high priorities from the study that will add value to different industries or impacts on different industries. The study will be completed late May/ early June. Emma will look into setting up meetings between MDA and Namoi Unlimited.
