5. REPORTS

5.1 MDA Report - Tony Banks (via phone): Topics highlighted / of significance to MDA Region 6

MDA Basin Community Leadership Program (BCLP):

- The MDA remains committed to the ongoing development, capacity building and support to the regional communities and local Government bodies throughout the MDB.
- The MDA has been funded by the Government to facilitate a Basin Community Leadership Program (BCLP) in 15 MDB communities which have been identified as being most impacted by the recent water policy changes.
- Region 6 has been identified as one of these main MDB regions who have been impacted; and as such, the MDA will be facilitating a BCLP workshops within Region 6 at: Lower Lakes across the 26-27 May 2020.
- Additional information packs will be sent out in the coming weeks for Regional awareness and review.
- Advertising and recruitment campaigns will commence February 2020 with a target of finalising the selection panels and identifying up to 15 aspiring community leaders at each of these locations later in March 2020.
- Any further queries can be directed towards the MDA executives pending the information packs being released in the coming weeks.

Significant media coverage and interests growing across the MDB toward the various State's responses and position on the Murray Darling Basin Plan:

- The MDA has been working hard to keep the Regional Chairs and Executives aware of the
 various reporting and statements being released right across the MDB for better situational
 awareness and informed decision making.
- The current dynamics involving the drought impacts, WESA additional recovery targets and the various State's levels of support to the plan have been very fluid.
- The MDA has released several communication reports which all highlight the ongoing need for the MDA regional forums / chairs to continue to monitor and report the growing concerns and discussions being held by MDB community members.
- Noting the upcoming Ministerial Council meeting between Federal and State leadership stakeholders, the MDA continues to reinforce the need for all policy and decision makers to

- better involve the communities and local Government bodies in every step of the MDB Plan
- The MDA; like the majority of the MDB local government bodies and communities are closely monitoring the outcomes of the MINCO meetings and any progress being made by the State's over the coming weeks.

5.2 Chair's Report – Cr Melissa Rebbeck

The Chair, Cr Rebbeck, informed the members that the MDA CEO is waiting on a South Australia State Government position in regards to the claims made by NSW before responding to these claims officially.

In the meantime the Chair stated the importance toget a Region 6 position, including input from relevant stakeholders (e.g. Coorong related stakeholders). Mayor Lewis suggested that a collective voice is important which would include South Australian and National MDA.

The Chair further provided an update on the MDA National Conference that was held in Toowomba, 22-24 October 2019. Over 140 Community leaders attended the conference and the presentations were excellent. The presentations focused on the theme of "Regeneration for a Healthy Basin". Of the 21 motions only one was not carried.

Action arising:

• Interim Executive Officer: To send out a the MDA Board Report on the Conference and the notes made by the Chair, the CEO Rappensberg and Cr Scott to MDA Region 6 members.

A member of Region 6, Stephen Packer, attended the public forum for the ACCC Murray-Darling Basin water markets inquiry in Murray Bridge on Friday, 29 November 2019. While Region 6 did not submit an individual submission to the ACCC, our Chair provided Region 6 related comments to MDA's CEO, Emma Bradbury, for her consideration and inclusion into a MDA collated response.

The Chair stated the important work carried out and the short timeframes of responses at times. The Chair thanked the Executive Officer and Stephen Parker for sharing the work load and attending meetings where required.

Actions arising:

- Chair to provide the following Region 6 related issues to the next MDA Board meeting on Monday 16/12/19:
 - That the MDA responds to claims made by NSW that South Australia uses 97% of high security water to highlight that in return NSW has access to 96% allocation of high security water
 - Environmental water is required to fullfil Australia's international obligations under the RAMSAR agreement for international wetlands
 - To support 'myth busting' to counter claims made by NSW
 - Call for NSW to submit their Water Resource Plans.

5.3 Strategic Advisory Group Report – Mayor Lewis

Mayor Lewis encouraged all Region 6 Councils to ensure that the funding for a 0.5 FTE Executive Officer position will be made available as this is of high importance.

Mayor Lewis provided an update on the LGA meeting where the name of the LGA was discussed at length and eventually supported. He further stated that it is important to include the LGA as a strong partner as they have a direct link to state ministers. A joint depution will be submitted next year and that Region 6 members should watch this space.

The slumping of river banks was identified as a big issue where the state government walked away and left Councils with the responsibility and associated costs (refer to item 6.2 below for further information).

5.4 Secretariat Report - Monika Rhodes

• Interim Executive Officer, Monika Rhodes, presented the draft RegiSymposium Report.

Actions arising:

6. GENERAL BUSINESS

6.1 Update on the MDA National Conference – Chair Cr Melissa Rebbeck (Alexandrina)

The report on the MDA national conference was provided during the Chair's report (refer to 5.2).

6.2 Riverbank collapse or slumping (Rural City of Murray Bridge)

Stephen Packer updated the membership on the issues of riverbank collapsed along the Murray River:

- Approximately 160 areas of slumping are recorded along the Murray River.
- South Australia Government no longer takes responsibility and has passed this back to Councils.
- The slumping has an impact financially and socially and it is unclear if insurance will pay.
- At what stage would it become a risk to council.

Mayor Lewis responded that Region 6 should consider support through the LGA.

6.3 ACCC Murray-Darling Basin water markets inquiry— feedback from public forum held at Murray Bridge — Stephen Packer (Rural City of Murray Bridge)

- Stephen Packer stated that around 100 people attended the public forum, many of whom were irrigators. Concerns included:
 - o investors and the ethics of the water trade
 - o the MDBA is over allocated, not enough water for all demands
 - NSW and Vic have allowed permanent plantings but do not have the water to service them
 - how the water was tied to the land which became unbundled
 - o difficult for farmes to understand when to buy and use the water as bigger investers have the opportunity to do the research:
 - how to understand the water and storage
 - when it flows: depending on releases, water can be traded, possibly only for a few hours which is difficult for a farmer/irrigator to take advantage of as window so small. once it flows water availablility is only for a short hours when released – hard for farmers to know when This suits investors with time and capital
 - increase of price due to investments and available water
 - tweakings of the policy to create fairness also creates anomolies which are hard to follow and understand, ownership, usage, availability and the like, many different rules apply
 - o most water along the river in SA and all water through the barrages is Commonwealth Environment Water Holder water and not available for anyone
 - o all water coming down Murray is from Southern Basin as no water in Northern Basin.

6.4 Lower Lakes and Coorong Boating, Tourism and Environment Group – feedback from meeting held on 10 December 2019 – Stephen Packer (Rural City of Murray Bridge)

Stephen Packer provided a brief overview of the main issues identified in the meeting:

- DEW update:
 - o no rainfall; no inflows
 - very low outflows
 - o barrages open 4 hours a day, closely monitored
 - water is being traded out of SA
 - o modelling now for 0.5AHD (currently at 0.7AHD) and 0.0AHD given no inflows.
- This will recreate slumping problems.
- NSW claim of the South Australia's 100% high secure water without mentioning that NSW itself has 96% of high secure water.
- BOM not reporting water availability in NSW accurately, stating no water available.
- Note: water reporting and myths within SA also exist, Riverland irrigators versus Lower Lakes.
- Reduction of water quality and fish kill.
- Mythbusting: How to successfully get the information out to media and wider audience. A
 social media page was discussed as a medium to combat misinformation and to provide
 accurate inforantion instead from the SA perspecitve. Reference to the MDBA fact sheets
 was made and how these could be included.
- MDBA: Phil Duncan appointed as Chair.
- Federal parliamentary Select committee unable to attend barrages due to Catastrophic Weather conditions on day of visit, rescheduled to March 2020.
- Mick Kealty's role being extended to entire Basin, including review and water sharing as for Northern Basin.
- Report from Kealty released on Nthern Basin re water management damning.
- Question as to who is at fault, plan or State management.
- Updated scientific report to come re Lakes and salinity.

- Lock Zero: short discussion on how the Lock Zero plans came up during the Millenium drought. May never happen due to unstable river floor.
- Length of river Art project, looking for local people to talk to.
