8. REPORTS

8.1 CEO's Report – via phone conference

Minutes of Murray Darling Association Board Meeting No. 383 – Friday 1st February 2019 & CEO's Report provided as separate hard copy documents at meeting.

Emma Bradbury announced that this project had been successful, and the positive feedback from Minister Littleproud and the funding body. This project will be enable provision of Murray Darling

Basin leadership at the local level. This project will target regional leaders across communities to improve their knowledge about Murray Darling Basin processes, and empower them to create projects.

The Murray Darling Association has changed website service provider which should improve the accessibility of the web site. James Marshall has commenced with the Murray Darling Association to work on development of member services, position papers, and communication.

Emma Bradbury and Chair David Thurley presented a Murray Darling Basin Business Case to several Ministerial Offices in Canberra in regard to the value proposition offered by the body

Councillor Melissa Rebbeck asked Emma Bradbury about the preparation process in the lead up to the Toowomba MDA AGM and National Conference.

Region 6 need to prepare in the lead up to Toowomba MDA AGM and National Conference ;

- State and Regional positions to present, motions to present, what presentations we would like to see.
- Region 6 need to ensure that all motions and positions are aligned with Member Council policy.
- A motion supporting work to ensure the ongoing health of the Northern Basin that is imperative to the ongoing health of the Southern Basin.

Councillor Peter Smith stated that we need to find ways to support the Northern Basin. This support may be a position to the next Federal Government that action must be taken or the Northern Basin may not recover. The problems in the Southern Basin will get worse if the Northern Basin is not fixed.

Emma Bradbury responded with;

- We need to keep looking at the system holistically. This is being done through the Catchments and Communities workshop series.
- This year's national conference is being hosted in the Northern Basin, to help improve basin wide understanding of this region. A lot of the discussions will be focussed on the Northern Basin.
- The importance of a holistic approach. We need to work as a whole Murray Darling Basin community, working at a high level.
- Working to support the NSW Government on their non compliance undertakings, and managing the sustainability of the expanding irrigation footprint.
- Murray Darling Association has made an approach to the incoming New South Wales Water Minister.
- The Murray Darling Association Board has resolved to seek responses from each Region Chair to contribute to an overall Murray Darling Association response to the Murray Darling Basin Royal Commission Report.

Councillor Vern Leng asked Emma Bradbury a question about boundary realignments.

Frank Tuckwell asked Emma Bradbury a question about the Upper House inquiry into the Clarence River Storm Water Basin Scheme. This may now have relevance to the Northern Basin. Emma suggested to have a look back through the resolutions of the last few AGM's, and for Region 6 to put forward a considered motion in regard to this matter to the AGM.

District Council of Yankalilla correspondence. Emma Bradbury has had an approach from this Council. She encouraged District Council of Yankalilla to attend Region 6 Meetings.

ACTION: Alexandrina Council to make an approach and invitation to District Council of Yankalilla. Councils are free to join the Region that best fits their identity.

9.2 Continuity through Local Government Elections / Vice Chair position? Julie Barrie

Julie Barrie said that ongoing leadership is important to keep Region 6 running. This became an issue at the last Local Government election due to the non re-election of two key leading members of Region 6. Region 6 was not represented on the Murray Darling Association Board during this time, and Region 6 momentum was lost.

Julie suggested that we put forward to the two motions to change this process at to the Murray Darling Association Board level, rather than changing the Region 6 Constitution.

Julie Barrie moved that Region 6 write to the Murray Darling Basin Board asking for change in process whereby an existing Regional Chairperson be allowed to continue in the role of Chair until the following AGM of Region 6, regardless of their position in Local Government.

Julie Barrie moved that Region 6 write to the Murray Darling Association Board asking for a change to process whereby the deemed Vice Chair or nominated member be allowed to attend National Board meeting in the absence of the usual Chairperson.

Anne Liddell expressed concern about the governance of this approach in regard to the Region 6 relationship to Local Government.

ACTION: Malcolm Downie suggested that these motions are taken back to the Region 6 Executive to come up with some recommendations to go forward.

Moved by Malcolm Downie, seconded by Councillor Vern Leng.

Barb Cowey, Drought Response with Regional Coordinator, Murraylands and Riverland PIRSA / Regions SA

Barb Cowey discussed some recent Federal Announcements and programs;

- Tailem Bend has been announced as a 'trusted advocate network'. Businesses might be identified as advocates for mental health.
- The Murraylands Drought Network has been established which is attended by Tracey Strugnell and Mayor Paul Simmons (Coorong District Council). There is interest in targetting whole families in drought, not just the men.
- This work supports the work of the Farm and Business Mentors. Their aim is to ensure people are OK and are connected to the resources available.
- Barb is attending a Bureau of Meteorology big data workshop next week, and is looking forward to learning about the resources available.
- The data for the next few months both climatically is not terribly positive. Late breaks to the season are predicted.
- Barb was impressed with the tone of the conversation at the recent Irrigation Workshops. The River Murray Water Allocation Plan sign off by Minister Speirs has provided some safe guards. We are in a better position than we were 15 years ago. River management has improved.
- The importance of 'one river' thinking going forward. Already a better approach this time that during the milennium drought.
- Barb Cowey and Kym Walton have been completing work comparing irrigation crop water use and land footprint comparing 2009 and 2018 data. This information is available upon request. This includes work by Mark Skewes of SARDI about in what month what crop requires what water. Currently the Clare and Barossa Valley Irrigation areas are not included in this data.

ACTION: Barb Cowey to provide this presentation to Tracey Strugnell to forward to Region 6.

ACTION: Consider Tom Rooney and Stuart Peevor from Waterfind as potential Symposium or National Conference speakers.

- A key difference between this dry period and the the milennium drought is that commondity prices are in a better place now than they were then.
- Barb suggested that someone like Tom Rooney and Stuart Peevor from Waterfind would be a valuable speaker at a Symposium. Knowledge of water trading could be improved in the irrigator audience.

Councillor Melissa Rebbeck said that this body of work could be well worth presenting at the Symposium, or the National Conference at Toowomba.

Councillor Melissa Rebbeck commented that it would be valuable if stream flow reduction data could be demonstrated. This would be very powerful region by region.

Thank you for your letter of 15 April 2019 on behalf of the membership of the Murray Darling Association Region 6 to the Hon. David Littleproud, Minister for Agriculture and Water Resources, highlighting issues of concern arising from the findings of the Murray Darling Basin Royal Commission Report. As the government is currently in an election period, I am responding on behalf of the Minister.

The issues that you raise in your letter have also been highlighted by the Productivity Commission (PC) and the South Australian Royal Commission. On 25 January 2019, the PC released its final report on its inquiry into the Basin Plan. The PC's inquiry is a statutory requirement under section 87 of the *Water Act 2007* to assess the effectiveness of the implementation of the Basin Plan and associated water resource plans. The Government is carefully considering the findings and recommendations of the PC's report.

As you are aware, on 31 January 2019 the South Australian Government publicly released the final report of the South Australian Murray-Darling Basin Royal Commission. On 20 February, the board of the independent Murray-Darling Basin Authority released a statement in response to the Royal Commission, available at mdba.gov.au/sites/default/files/pubs/MDBA-response-SA-Royal-Commission-Feb-20.pdf.

The Prime Minister has agreed to Murray-Darling Basin First Ministers discussing the findings and recommendations of the PC inquiry and the Royal Commission. It is anticipated that the Basin First Ministers meeting will take place alongside the next meeting of the Council of Australia Governments to be scheduled in due course.

In regard to climate change, the Murray–Darling Basin Authority (MDBA) is working in partnership with the independent Advisory Committee on Social, Economic and Environmental Sciences (ACSEES) to design a research program to advance our understanding of climate change, and continue MDBA's collaboration with leading research bodies, scientists, government and independent experts. The MDBA has recently released a discussion paper which explains the impact of climate change across the Basin and explores how the current Basin Plan settings actively manage climate change. The paper also sets out some focus research questions the MDBA will be investigating through its climate change program in the years ahead.

As you point out, the Basin Plan is a critical reform. It aims to reset the balance between environmental and consumptive uses of water, and establishing a new framework for sustainable water resource management. Drought is the time to truly test the Basin Plan, and its

agriculture.gov.au ABN 24 113 085 695 value is clearer now more than ever. This includes delivering positive environmental outcomes while still minimising the socio-economic impacts of the Basin Plan and providing more stability and security to Basin communities.

So far the government's water infrastructure efficiency program has recovered over 700 gigalitres (GL) of water for the environment. These are genuine water savings, transferred to the Commonwealth in the form of water entitlements. In total, more than 2100 GL of water has been recovered for the environmental health of the river system.

This environmental water has been used in over 750 planned watering events in the past four years, with environmental water holders working together to get water to priority areas at the right time. The MDBA's 2017 Basin Plan Evaluation has documented positive ecological responses from the delivery of environmental water. There are early signs that five years into the implementation of the Basin Plan the rate of decline of waterbird numbers has reduced, native fish have responded positively and the health of the Basin's rivers and floodplains are being revived. Further information on the outcomes of the 2017 Basin Plan Evaluation can be found on the MDBA website.

If you wish to raise your matter again you should do so by contacting the incoming government.

Dear Minister Littleproud,

We write on behalf of the membership of Murray Darling Association Region 6 (MDA-R6) to highlight those issues of most concern to our region arising from the findings of the Murray Darling Basin Royal Commission Report (the Report), and to seek your counsel on how a Federal Liberal Government will seek to address these concerns within the context of Basin Plan implementation.

MDA-R6 represents the interests of the Lower Murray, Lakes and Coorong region. Current membership of MDA-R6 includes Alexandrina Council, Coorong District Council, Rural City of Murray Bridge, and Tatiara District Council along with a number of individual members.

Our Region has been, and remains, a vocal and consistent supporter of the Basin Plan. We understand that the political compact giving rise to the Basin Plan was hard won, and would not be easily re-established should there be a push to either pause or rewrite the Plan. We also welcome the decision made last December to allocate \$70m million of South Australian State Priority Project funds to support the long-term health of the Coorong via delivery of the Healthy Coorong, Healthy Basin Action Plan.

Nonetheless, the Commissioner's findings (many of which reflect issues raised by Region 6 during the consultation period) have generated feelings of deep concern within our community. Two months have now passed since the Report was handed down and our communities are anxious for both the South Australian and Federal Governments to respond **in full** to the Commissioner's findings and recommendations. We refer to the top three issues and recommendations of greatest interest to MDA-R6 as follows:

<u>Recovery of the 450GL</u>

For some time, MDA-R6 has been cautioning against "death by a thousand cuts" with reference to the increasing number of legislative and policy constraints being imposed on recovery of the 450GL. Whilst MDA-R6 continues to support the Basin Plan, the Commissioner's findings in relation to the environmentally sustainable level of take (ESLT) do reinforce the need for all Basin governments to remain sharply focused on achieving full recovery of the 450GL. To this end, MDA-R6 has indicated our support for a repeal of the 1500GL cap on water buy-backs in order to maximise the available options for achieving this water recovery target. We also express our continuing concern that the new socio-economic neutrality criteria for efficiency measures will in effect, set the bar so high as to

make recovery of the full 450GL unachievable. We also note the Murray Darling Association Board position on socio-economic neutrality criteria that seeks Local Government agreement.

<u>Climate Change</u>

In our original submission, MDA-R6 expressed concern that current Basin Plan sustainable diversion limits (SDLs) will in fact become quickly *unsustainable* in a changing climate. Observed climate trends within the Basin include an 11% decline in April-October rainfall across south-east Australia since the late 1990s, an increase in evaporation associated with higher than average temperatures, and an exacerbated corresponding reduction in stream flows. It will be absolutely critical that future iterations of the Basin Plan properly account for projected climate change including trends and associated risks. We seek assurances that a Federal Liberal Government will support (1) resourcing of climate change research to inform future water management in the Basin, (2) the development of a comprehensive climate change adaptation plan for the Coorong, Lower Lakes and Barrages, and (3) the achievement of suitably ambitious 2030 and 2050 emission reduction targets at both State and Federal level with a view to meeting our internationally shared responsibility to minimise the scale of the adaptation challenge.

<u>Structural Adjustment & Regional Development</u>

We agree that water recovery should be accompanied by complementary investment in Basin Communities. In a changing climate, communities throughout the Basin will need continued assistance to adjust to a future with less water. Grassroots community and industry groups in our region (such as Mallee Sustainable Farming, Fleurieu Farming Systems Incorporated, Coorong Tatiara LAP and Goolwa to Wellington LAP) are investing significant time and energy in adaptation research projects, with a view to ensuring a prosperous future for our primary production sector. We welcome the recent Budget announcements with respect to agricultural stewardship, innovation and drought response, and urge all Basin governments to co-invest in research and programs which will improve the long-term adaptive capacity of the Basin's agricultural sector and regional townships.

Hoping for rain is not enough. Rather, it is our hope that the Report will be treated by all Basin governments as an important catalyst for making meaningful improvements to Basin Plan implementation over the next five years to 2024 and beyond.

We call on the Federal Government to put aside jurisdictional formalities by providing a full and meaningful response to the Commissioner's findings and recommendations and trust that you will give due consideration to the issues raised in this letter whilst preparing that response.



STATES NEED TO PUT IN WORK TOO: LITTLEPROUD

FEDERAL Water Minister David Littleproud said a governmental response to the Productivity Commission report into the Murray-Darling Basin would come, but the states also needed to pitch in.

"I anticipate a response to the PC report before the end of the year, but ultimately it is a matter for all basin ministers and the Commonwealth to respond to," he said.

"I have met with basin communities, who wanted greater confidence and accountability in water markets, which is why I will commission the Australian **Competition & Consumer** Commission inquiry.

"I am open to the recommendations of the PC report but they need to be carefully considered with the states to make sure there are no unintended consequences that could leave basin communities worse off."

The MDB Authority said Basin governments would need to form a consensus.

"We welcome the PC's call for stronger and more effective collaboration between all Basin governments because we'll get more success working together rather than working in isolation," MDBA said in a statement.

The Almond Board and SunRice chair Laurie Arthur have each called for caution ahead of new water allocations and developments, saying more research was needed.

Notification of Murray Darling Association AGM – 23rd of October 2019

Motions for the AGM – 23^{rd} October 2019 must be in by the **<u>21st August, 2019</u>**.

Water Allocations and Announcements – 15th of May

The minimum opening allocation for River Murray irrigators in the 2019-20 water year is projected to be 22 percent of the number of entitlements held.

Because minimum opening allocations in April were projected to be below 50 percent, **private <u>carryover</u>** will be made available to eligible licensees, allowing up to 20 percent of unused water from 2018-19 to be carried over for use in 2019-20.

This reflects the extremely dry conditions across the Murray-Darling Basin.

ANAO Audit into the procurement of strategic water entitlements: looking at the design of the current policy for water buy-backs, and whether its implementation has been effective Emma Bradbury - MDA 9th of May 2019

Please find following information in relation to a review underway into the current policy design for water buybacks, and the procurement of strategic water entitlements – both of which have been matters of particular interest to our members and the community at large in recent months.

On 29 April 2019 the <u>Auditor-General for Australia advised</u> that that an audit will be conducted into the procurement of strategic water entitlements following allegations concerning the purchases of water for environmental flows in the Murray-Darling Basin. This performance audit has now formally commenced and is currently forecast to table in Parliament in December 2019..

The criteria for this audit are listed at <u>https://www.anao.gov.au/work/performance-audit/procurement-strategic-water-entitlements</u>. The performance audit will look at the design of the current policy for water buy-backs, and whether its implementation has been effective. Input to the audit can be done through the following link: <u>https://www.anao.gov.au/work/performance-audit/procurement-strategic-water-entitlements</u>.

The objective of this audit is to assess whether the strategic water purchases by the Department of Agriculture and Water Resources were conducted consistent with government policy, supported by appropriate program design, were planned and executed appropriately, and, achieved value for money. The auditor is seeking input from members of the public, with particular value placed on information that deals with significant matters or insights into the administration of the subject of this audit.

The board will be briefed on this audit at the upcoming board meeting on May 20th, with regions encouraged to put the matter on their regional agendas

Water Buybacks: The Sunday Project - The Project Took A Plane Over The Property At The Heart Of The Water Buyback Scandal Emma Bradbury - MDA 6th of May 2019

The Sunday Project last night ran a story on the \$80m purchase of overland flows. In essence the story reveals that the purchase committed the owner to remove levees that divert overland flows to Kia-Ora – and allow them to flow back into the Balonne. The Project reveals that while the Qld Govt affirmed that the works had been undertaken, it would appear that the levees are still in place, with only one breech reported to have occurred during the last flood event. No further remediation works appear to have been done.


