10.1 Refresh, Update and Induction for Members of Region 6 Delegates Shen Mann

Chair Melissa Rebbeck asked what the process is for moving forward for the Strategic and Communciations Plan. Shen Mann responded that this is up to the Region 6 Executive and Executive Officer to work on the delivery of this plan. This is not time limited.

Councillor Michael Scott asked the group whether Region 6 still want to give their full support to the Murray Darling Basin Plan. Keith Loeser added further comment to this.

CEO Glenn Rappensberg added that he felt the previous perspective had been that a Plan is better than no plan. We need to analyse whether the Plan is the issue, or the way it is being implemented. A key issue is however the lack of consideration of climate change.

Chair Melissa Rebbeck made comment on the climate change elements of the Royal Commission into the Murray Darling Basin Plan.

Shen Mann suggested that we should listen to the perspectives of our guest speakers.

Mayor Brenton Lewis also backed Glenn Rappensberg's comments. He urged that Region 6 not walk away from the Murray Darling Basin Plan. That <u>a</u> plan, is better than no plan.

10.2 Discussion of Murray Darling Basin Strategic Planning Workshop

Heather Barclay, Councillor Vern Leng, Mayor Brenton Lewis, Tracey Strugnell

Item arising from MDA Strategic Planning Workshop, suggestion from Region 7 (City of Mitcham-Mayor Heather Holmes-Ross) that the South Australian Regions aim to meet quarterly.

Mayor Brenton Lewis commented that 12 Regions came together, with the overall feeling was the issues that united us were stronger than those that divided us. There was an acknowledgement of the need to improved the financial position of the Murray Darling Basin.

Heather Barclay said she took away that the Murray Darling Association is transforming and growing in strength in its ability to provide advocacy. 47% of the Councils in the Basin are MDA members. A key reflection was that we need to encourage more Councils, and our neighboring Councils to become members. A highlight was the SA Region representatives all met on the Sunday. This was a terrific opportunity to build relationships with neighboring Regions.

Executive Officer Tracey Strugnell thanked Coorong District Council, Rural City of Murray Bridge, and Alexandrina Council for providing the opportunity for her to attend the Strategic Planning Workshop.

10.3 MDA Inter Regional Meeting

Connecting Catchments and Communities Menindee to the Murray Mouth

11 GUEST SPEAKERS – PANEL FORMAT

To assist with our Region 6 refresh and induction process Angus, Peter, Monique, and Michelle were invited along to introduce themselves and to explain their roles.

Angus MacGregor, Manager - Healthy Coorong, Healthy Basin (DEW)

Angus introduced himself as the newly appointed Manager of the Healthy Coorong, Healthy Basin (HCHB) project. Angus explained his background, including in the administration of the CLLMM Recovery Project from 2011-2017. The Federal Government has quarantined \$70 million toward the Coorong, with \$2 million earmarked to progress and finalise an action plan.

Angus explained that Department for Environment and Water's (DEW) intention is to undertake a detailed consultation and planning process to identify the best options for the funding. This will commence over the coming weeks and months and DEW is open to suggestions about the best way to do this.

Angus discussed the Coorong Summit and the Goyder Report. These reports will inform the investment of the \$70 million, but Minister Speirs has also indicated a desire for grass-roots, community-led involvement. The focus will be on the long-term health of the Coorong, with a focus on the Southern Lagoon.

A range of sub-projects are likely to be developed under the HCHB umbrella, including:

- Research and investigations; On-ground works;
- Operational tools and systems;
- Feasibility investigations of large infrastructure solutions;
- Aboriginal partnerships; andCommunity engagement and capacity building

Councillor Vern Leng asked Angus about whether funding the use of desalination plant was coming out of the \$70 million? Angus said it is not.

Mayor Brenton Lewis asked about where the \$70 million figure came from? Angus explained that the figure was the approximate balance of the \$610 million State Priority Project funding commitment made in 2008.

Councillor Brenton Qualmann asked what the time frame is for the delivery of the \$70 million projects? Angus explained that the current end date for the project is 2024, however projects investigated as part of this project may be delivered beyond 2024.

Tracey Strugnell asked whether there was any likelihood of devolving of funding to other bodies such as the Coorong Tatiara Local Action Plan or Councils for the delivery of projects. Angus answered that community delivery was being considered.

Councillor Vern Leng asked whether the Lake Albert to Coorong Connector concept will be looked at through this project. Angus said that a number of large infrastructure concepts have been identified for potential feasibility investigation under the HCHB project, including the Lake Albert to Coorong Connector. Angus indicated that DEW is open to revisiting previously investigated concepts, including that of a Connector, to undertake an objective assessment of their potential impacts on the Coorong.

Lorraine Leese asked about the Terms of Reference for the project. Angus explained that the final project scope / terms of reference for the project were still being developed, but that the focus will be on the ecological health of the Coorong, with a focus on the Southern Lagoon.

Councillor Brenton Qualmann asked what the time frame is for the delivery of the \$70 million projects? Angus answered that the current date for the project completion is 2024, however projects developed as part of this project may be delivered beyond 2024.

Tracey Strugnell asked whether there was any likelihood of devolving of funding to other bodies such as the Coorong Tatiara Local Action Plan or Councils for the delivery of projects. Angus answered that community delivery was being considered.

Councillor Vern Leng asked whether the Lake Albert to Coorong Connector concept will be looked at through this project. Angus said that this project will be looked at freshly under the Healthy Coorong, Healthy Basin Project.

Lorraine Leese asked about the Terms of Reference for the project. Angus answered that the focus will be on the ecological health of the Coorong, with a focus on the Southern Lagoon.

Michelle Campbell, Local Engagement Officer (Cwlth Environmental Water Holder)

Michelle explained her role and that of the Commonwealth Environmental Water Holder (CEWH). They can manage the water in three ways, use carryover, trade water and deliver/use water. The CEWH relies on the State Governments to deliver water. Water remains the responsibility of the States under Australia's Constitution Section 101.

The CEWH works in conjunction with many other bodies eg. Banrock Station, SA MDB NRM Board, Nature Foundation SA, and Renmark Irrigation Trust to deliver water for the environment. She explained that in the Southern Basin the delivery of water is simpler due to the range of structures, locks, regulators and volume of water held in large storages. This is more difficult in the Northern Basin. The aim is to release water in line with natural cues, or rainfall events.

Michelle explained that there is currently small volumes of water for the environment in the Darling system, making it difficult to help the fish kills. However there is sufficient water in the Murrimbidgee system to have a positive impact on the fish kills in this area.

Michelle was asked how are we going to mitigate blue green algal blooms and fish kills given it has been an issue in the Basin over such a long period of time.

Michelle answered that one of the tools we have where there is a re-occurring problem is the CEWH can sell water in a catchment where there is more than required, and buy water in the catchment where it is needed more.

Keith Loeser asked what happens when all of the states have exhausted their licences, is there a clear path from there?

Michelle said that there is a complex process that is entered into called 'special accounting' when South Australia's allocation cannot be met.

She reflected that it is now critical that local communities are very well informed about their local conditions, and are ready to debate intelligently and maturely with other basin dependent communities in other parts of the Basin.

Monique White, Assistant Director – Engagement (Murray Darling Basin Authority)

Monique spoke to the 450GL component. The change is around the socio economic consideration of projects that are developed for implementation.

The Murray Darling Basin Authority is preparing a report in response to the Royal Commission.

The Productivity Commission found that progress had been made in the implantation of the Basin Plan, and highlighted areas where progress was not occurring quickly. One of the key recommendations was that compliance be separated from the other areas of work of the MDBA.

The MDBA do not go out and check water meters or use, but they do oversee the States to ensure that they are doing this compliance work. The MDBA has identified that Water Resource Plans are at risk. Michelle explained that the States develop the Water Resource Plans which are then handed to the MDBA for assessment.

Monique reported that the MDB Plan did look at dimate change over time, as will the Adaptive Water Resource Plans which are due for completion between June and December 2019.

Monique said the Sustainable Diversion Limit Projects are going ahead to be delivered by 2024.

The Northern Basin initiatives are ongoing, but the 450 GL with the socio economic components may be difficult to implement.

Councillor Vern Leng asked whether given the current climate are the MDBA going back to the drawing board in regard to the Sustainable Diversion Limits.

Monique answered that in the Northern Basin the Groundwater and Water Resource Plans are currently being completed. Having input into these Plans during the consultation plan is important.

Chair Melissa Rebbeck asked "The Bureau of Meteorology and the CSIRO worked together on a report for the International Panel on Climate Change (IPCC) which from memory showed a significant difference in rainfall decline and streamflow over the last 20 years for south eastern Australia. Has this been or can this be considered by the MDBP for their SDL and ESLF? "

Monique answered that the MDBP are working closely with CSIRO to enhance their knowledge in this area.

Councillor Peter Smith asked whether this group would like to write a letter of thanks to the past Chair of the MDBP Neil Andrew. Chair Melissa Rebbeck answered that this will be discussed at a meeting of the Region 6 Executive Group.

Michelle suggested that it may be of value to ask someone along to explain the new Water Connect Water Allocation Dash Board.

Chair Melissa Rebbeck opened the floor to questions.

Councillor Jeff Arthur made the comment that no new storage has been built in Australia in a very long time, except privately.

Monique said the work done privately is regulated by the States.

Lorraine Leese commented that the MDBP is a Plan in progress. Each State has their own water legislation as per the Commonwealth Constitution.

Darling River fish kill and failure of Basin Plan

The Lifeblood Alliance consists of environmental, Indigenous and community groups committed to keeping the rivers, wetlands and aquifers of the Murray-Darling Basin healthy for the benefit of current and future generations.

We wish to draw to your attention the overall environmental objectives of the Basin Plan as they appear in Chapter 8 Part 2 Section 8.04:

The overall environmental objectives for the water-dependent ecosystems of the Murray-Darling Basin are, within the context of a working Murray-Darling Basin:

(a) to protect and restore water-dependent ecosystems of the Murray-Darling Basin; and (b) to protect and restore the ecosystem functions of water-dependent ecosystems; and (c) to ensure that water-dependent ecosystems are resilient to climate change and other risks and threats.

We consider that the recent large fish kill on the Darling River indicates that progress towards these objectives is not being achieved, particularly in the Northern Basin, and these objectives will not be met by the Basin Plan, in its current form, when fully implemented.

We consider that the main reason for this failure of the Basin Plan has been caused by:

- The lack of climate change predictions in MDBA models
- The lack of a balanced approach in arriving at the Basin Plan final outcome
- Maladministration of the process of developing and implementing the Plan

We are concerned that the Basin health will be no better off despite the investment of \$13b.

For the Basin ecosystems to maintain resilience in the face of longer droughts and heat waves it is imperative that more water is returned to river systems and wetlands.

The outcome of the politically charged SDL adjustment mechanism will return as little as 2100 GL to the Basin when 4000 GL was estimated to be the minimum requirement based on good science.

The recent socio-economic strictures placed on projects to improve the efficient use of water across the Basin are not matched for the supply projects which lack detailed business plans and feasibility studies.

This is a prime example of the lack of balance in the Plan implementation process.

The development and accreditation of Water Resource Plans is another key area of concern. For example NSW has water sharing plans on exhibition that base water allocation decisions on the worst drought prior to 2004, have no rules to protect environmental water (although this was a key toolkit measure in the Northern Basin Review), have no volumes for floodplain harvesting extraction and have not completed Aboriginal nations consultation.

We are very concerned about the scale of the impact of the recent Darling River fish kills on the Murray Cod population, a species listed as vulnerable under the Environment Protection and Biodiversity Conservation Act 1999. There is a National Recovery Plan for this threatened species that requires:

- A thorough understanding of the ecological processes relating to flows that result in improved recruitment into adult Murray Cod populations and the implementation of appropriate river flows.
- Develop and implement flow management practices to benefit recovery of Murray Cod populations.¹

We do not believe that the Basin Plan has taken these requirements into account.

We request a meeting with you to discuss how the Basin Plan can be improved and the actions needed to prevent further threats to threatened native fish populations.

Dear Ms Smiles

Thank you for your correspondence of 25 January 2019, on behalf of Lifeblood Alliance, regarding the Murray-Darling Basin (the Basin) and the recent fish deaths in the Darling River system.

I share the community's concern about the recent fish deaths in the lower Darling River and northern Basin. It is a terrible reminder of the effects drought can have on the environment. I also understand the ongoing challenges posed by the prolonged drought conditions for people in western New South Wales (NSW) and southern Queensland. The fish deaths we have seen over the summer months appear likely to have been caused by low dissolved oxygen levels caused by a range of factors including the breakdown of water layers in the river, decomposition of organic matter, algal blooms and the high temperatures followed by cooler periods. Unfortunately, there is still a risk of further fish deaths if there are not significant flows within the system soon.

The drought has been particularly harsh on the Darling River system, where there have been little to no inflows. In the Menindee Lakes, storage now sits below four per cent. The NSW Government is leading the investigation and response into the fish deaths. We have offered NSW any assistance it requires to respond to incidents and to rebuild fish stocks when it rains.

In view of the ongoing drought conditions and the potential for further fish deaths it is important that all Basin jurisdictions work together and do all that we can. As an immediate response, the Commonwealth and Basin state and territory governments developed and implemented an action plan to mitigate the risk of further fish deaths. These actions include:

- monitoring of water quality at a number of sites in the Lower Darling
- installation of aerators in a number of refuge sites
- fish rescues by NSW Fisheries at several locations
- delivery of a small environmental watering event in the lower Murrumbidgee to improve water quality.

The Action Plan is available on the Murray Darling Basin Authority's website at: mdba.gov.au/sites/default/files/pubs/Response-fish-death-events-recommended-action%20plan-2019.pdf

I have also committed \$5 million to the development of a Native Fish Management and Recovery Strategy. The Strategy will support emergency response and recovery actions and additional research

into native fish stocks and their management – including the iconic Murray cod. This will help to protect native fish populations in the future, and build their resilience to future risks and threats. Regarding the Murray cod, the measures outlined above are supportive of its National Recovery Plan as a vulnerable species.

It is also important to continue to refine and improve our management practices so that we can mitigate fish deaths in the future. On 22 January 2019 I established an independent panel to identify the causes of the fish deaths and make recommendations within the framework of the *Basin Plan 2012* (Basin Plan) and Murray-Darling Basin Agreement. The independent panel released its interim report on 22 February 2019, which confirmed the findings of the NSW report into fish deaths. A copy of the report is available at: https://www.mdba.gov.au/publications/mdba-reports/independent-panel-assess-fish-deaths-lower-darling.

The Murray-Darling Basin Authority has also recently launched a new phase of work into the impact of climate change on the Murray-Darling Basin. Working with scientists and other stakeholders, the Authority will identify the impacts of climate change on the Basin and ensure the Authority's climate change work program will meet the future needs of the Basin's environment, communities and industries. A discussion paper is available online at: https://www.mdba.gov.au/publications/mdba-reports/climate-change-murray-darling-basin-plan-discussion-paper.

The Basin Plan is critical reform which resets the balance between environmental and consumptive uses of water, and establishes a new framework for sustainable water resource management. The Basin Plan was not intended nor expected to deliver immediate results. It is a long-term plan, the benefits of which will continue to accrue over many years. Drought is the time to truly test the Basin Plan, and its value is clearer now than ever. It's not about supporting the environment or farmers, but a case of balancing the long-term needs of both in this uniquely important part of Australia. This includes delivering positive environmental outcomes while still minimising the socio-economic impacts of the Basin Plan and providing more stability and security to Basin communities.

I note your concerns regarding the balance between supply and efficiency measures. At the Ministerial Council meeting in December 2018 significant progress was made in progressing both these measures. Ministers agreed to the socio-economic criteria and assessment process for the consideration of efficiency measures. To maintain momentum and encourage further uptake of efficiency measures, the Commonwealth also committed to commence an engagement program across the Basin to raise awareness of the opportunities available to stakeholders and build understanding of the environmental benefits of the program.

Basin governments are committed to working in close consultation with stakeholders and local communities through the detailed design and implementation phase of supply projects, using an adaptive management approach between now and 2024. Importantly, Basin Plan also provides for the MDBA to undertake a reconciliation adjustment in 2024, if any agreed projects are not delivered. The reconciliation will ensure that any shortfall is recovered so the environment cannot be short changed.

I note your concerns regarding the development and accreditation of Water Resource Plans (WRPs) and water sharing plans in NSW. As you may be aware, Basin state and territory governments are responsible for the development of WRPs. These are then assessed by the MDBA, before I conduct the final accreditation as Federal Water Minister.

Part of the requirements of the Basin Plan are that states undertake consultation with Aboriginal Nations, and show how they will demonstrate compliance with the sustainable diversion limits. The mechanisms for the protection of environmental water are being developed through toolkit and pre-requisite policy measures, and where required will be reflected in state planning and operational documents. I assure you that I will not consider the accreditation of water resource plans that do not meet the legal requirements of the Basin Plan.

I understand that there are elements of NSW WRPs that have not yet been completed. The jurisdictions acknowledged that the Basin Plan Sustainable Diversion Limits take effect from 1 July 2019 and, where necessary, will enter into agreements with the Commonwealth to ensure that other key accountability and transparency requirements under the Basin Plan are also operative from 1 July. Where relevant, jurisdictions will ensure that any water resource plans delayed beyond this date are submitted by 31 December 2019.

Please find below the response supported by MDA Region 6 to the Inquiry into the Water Amendment Bill.

MDA Region 6 support amending the Water Act 2007 to repeal the statutory limit of 1,500 gigalitres on Commonwealth purchases of surface water across the Murray-Darling Basin.

Recovery of the full 3200GL of environmental water as required by the Basin Plan is critical for the health of the entire MDB. In a changing climate, we fear that even full recovery of the 3200GL target will not be enough to guarantee a healthy river. The impact of the current eastern Australian drought has demonstrated the importance of securing additional environmental water as required by the Basin Plan.

Back in 2015 – for the reasons indicated in the Explanatory Memorandum of the current Bill – at least one local government member of Region 6 (Alexandrina Council) made a submission to the Senate Standing Committee on Environment & Communications expressing deep concern that adopting a 1500GL cap on water buybacks could undermine the efforts of the Commonwealth to implement the Basin Plan and increase uncertainty for the communities and ecosystems of the CLLMM region. At that time, our concern was that a legislative 1500GL cap on water buybacks would reduce flexibility of decision-making and make the task of recovering this environmental water considerably more difficult and more expensive. Those concerns remain.

For some time, Region 6 has been cautioning against the genuine implementation of the Basin Plan suffering "death by a thousand cuts" with the 1500GL cap on water buybacks being one of those cuts.

Region 6 is still recovering environmentally, socially and economically from the Millennium drought and with much of eastern Australia in the midst of another drought, we fear that our region will be negatively impacted once again unless as many options as possible are available to secure the additional surface water critical to the environmental, economic and social needs of our region.

Region 6 would welcome the opportunity to work with other levels of government to support agricultural industries across our region to survive and prosper in a drying climate with less surface water.



"My plan while chair is to push for all Basin States to remain focused on further environmental water recovery as required by full and proper implementation of the Basin Plan. At the same time I would like to see our community supported and informed of potential economical, agricultural and environmental impacts if the current drought continues".

"The findings of the recent Murray Darling Basin Royal Commission report raised real concerns about whether Basin Plan implementation will be enough to sustain the complex biodiverse ecosystem that the Murray Darling Basin supports. In addition to the focus on environmental water recovery, we urge our state and federal governments to utilise integrated approaches such as co-investment in threatened species research, habitat restoration and regenerative agriculture in order to achieve ecological and economic recovery across the Murray- Darling Basin".

Councillor Rebbeck has a wealth of experience in this area, having worked for two decades as an applied agricultural scientist at the South Australian Research and Development Institute, the University of Adelaide, and now through her own applied agricultural, climate and natural resource research and extension company. She is heavily involved in the agricultural industry and is strongly connected to regional farm and natural resource management groups.

Her research work over 20 years includes projects specialising in soil health, minimising frost impacts on southern Australian cereals, improving seasonal climate forecasts for South Australian primary producers and improving productivity in livestock systems. She was recently elected as a first-time Alexandrina Councillor and said her experience and passion for agricultural, water and environmental issues drove her to campaign.
