1. From the Chief Executive Officer's desk

Happy New Financial Year! I have now been just over a year in the role, it has certainly been a busy time for the MDA, and rapid entre into the world of water for me.

In 2014, this board set an ambitious agenda to undertake a range of operational reviews, including a review of the MDA's financial processes and position.

These reviews are now largely complete. The 2015 year-end financial reports will show some substantial adjustments as the review identified opportunities for a number of system wide improvements. I am delighted to report that, consistent with the organization's objectives in undertaking this work, the MDA is in a solid financial position, with a good cash flow, growing membership and sound management practices positioning us well for a year of growth ahead.

Other projects are ongoing as the MDA continues to position itself to meet the challenges of ensuring the Basin water resources are used and managed in a way that delivers the greatest sustainable economic, social and environmental benefit to our rural communities, farming sector and all who rely on our Basin's resources.

2. Projects

i) Social and Economic Impacts Data Collection and Assessment Project

In 2014 the Murray Darling Basin Authority (MDBA) partnered with the Murray Darling Association (MDA) in a joint project focused on collecting and assessing the suitability of information available from local government organisations within the Basin to assist the MDBA to analyse the trends and drivers of economic change over time as the Basin Plan is implemented.

This project was completed in June with a report, containing a number of recommendations submitted to the MDBA.

A key recommendation of this report that further work be undertaken to develop resources that will assist both local government and the Murray Darling Basin Authority to access and share information that will assist in the ongoing monitoring and evaluation of social and economic impacts of the Basin Plan, felt at the local level.

Following adoption by the board at its next meeting, a full copy of the report will be distributed to participating councils, and posted on the MDA's website.

ii) Towong Shire has taken over carriage of a small project to develop Murray Valley Trail signage.

iii) Wirraminna Education and Environmental Centre has taken over carriage of the NRM Education Plan Project.

The MDA does not currently have any dedicated project/field staff. However, the projects department is recognized as a valuable component of the MDA's stakeholder engagement and public education work. It will be a priority for the organisation to explore processes by which we re-engage in this space.

3. Staff Matters

I am delighted with our small but highly effective team, comprising Sandra Adams, Executive Assistant and office manager, Stan Gibney, Finance Manager and we now also welcome

Alice Russell to the role of Marketing and Communications Officer.

This is a wonderful team, with a high level of commitment and an excellent mix of skills and experience. Our organisation is very fortunate to have each of these individuals, collectively, driving some terrific outcomes for the MDA. We are looking forward to an exciting year ahead.

30 June 2015 saw the completion of Adrian Wells' long and distinguished service with the MDA, with Adrian unable to renew his contract due to ongoing health reasons.

A review of Adrian's achievements shows us that the organisation has some great work to do to maintain the standards in community engagement and creative education initiatives set by Adrian over almost 25 years.

We wish Adrian and Di the very best for a strong recovery and a happy retirement.

4. Murray Darling Foundation

The Foundation Committee experienced a number of challenges in the 2014/15 year, and in March/April the Chairman, Mr Brian Grogan tendered the resignation of himself and the current committee.

The board have appointed Cr Oscar Aertssen, R3 to the Chair of the Foundation, pending an election of a new committee in due course.

5. Meetings - external

In May, National President Greg Toll and myself travelled to Canberra and met with Hon Sharman Stone MP, Hon Michael McCormack MP, Mr Andrew Broad MP, Country Labor Executive team of The Hon Joel Fitzgibbons, Lisa Chesters MP and ..., the Hon Bob Baldwin MP, Parl Sec; Rhonda Dixon – Chief Executive Officer of the MDBA; Senator John Madigan; and CEWH David Papps and others in a series of meetings to advocate on a range of issues endorsed by the MDA membership. A brief of the issues is attached.

I am pleased to report that subsequent to those meetings, the Parliamentary Secretary Bob Baldwin announced the introduction of legislation to cap water buy backs, among other gains.

Cr Peter Jamieson, Chair of R7 made a member benefits presentation to Marion Council in South Australia.

The Chair and I have attended Regional meetings at the invitation of Regions 3, 7 and 8, and I have attended meetings in the Murrumbidgee Region, and Region 3 in Balranald. A particular note of thanks must go to the Mayor and staff of the Campbelltown Council for the genuinely warm welcome and gracious hosting of what was a well attended and very productive meeting Region 7.

The Chair and myself met with Neil Andrew and Barry Hart – MDBA, Chair and board member of the MDBA recently in Echuca.

6.2. New website

Region 3 – Chaired by Cr Oscar Aertssen met last month in Balranald. Thanks to the Mayor and staff for a warm welcome. We are looking forward to building stronger ties with the traditional owners across R3.

Region 4 – Chaired by Cr Judi Harris of Mildura RCC is due to meet in the near future, with a meeting date to be announced.

Region 5 – is going well and we welcome incoming Chair Cr Kevin Myers of the Mid-Murray Council. R5 is the only region that enjoys the membership and active engagement of every council in the region. A benchmark to aspire to!

Regions 6 – Currently chaired by Cr Frank Tuckwell will hold its AGM in August. Frank has announced his retirement from the Chair, and has been working incredibly hard to engage the region and ensure a strong and stable succession. Frank, and the Alexandrina Council have shown strong leadership and region 6 remains an active and vibrant region.

Region 7 – chaired by Cr Peter Jamieson recently met in Campbelltown with a very strong attendance, and showcased some excellent water management initiatives rolled out across their region.

Current advocacy issues Briefing notes June 2015

The Commonwealth Environmental Water Holder requires greater flexibility in water trade to facilitate investment in water efficiency infrastructure, and balanced availability of water for food producers.

Issues and opportunities

- Currently the Commonwealth Environmental Water Holder is restricted in both how and when he may trade allocation and what he can do with the proceeds of any sale.
- The independent expert panel tasked to review the Water Act 2007 (Cth) recently recommended (Recommendations 15 & 16) that section 106(2) of the Act be amended to allow trade revenue to be used for other environmental activities in addition to water acquisitions to maximise environmental outcomes.
- Investing in infrastructure projects assists in economic activity and the efficient use of water both on and off farms as well as in the environment.
- Investing in water saving infrastructure measures realizes more sustainable and equitable water savings than water buyback maximizing the value of every drop.

The current price of temporary water and its trajectory over recent seasons is constraining agriculture and is unsustainable.

Issues and opportunities

- The commodification of water is impacting water prices, with resultant detriment to the production of food and fiber.
- The more money farmers spend on water as a cost of production, the less they are able to reinvest in their communities and their future farming practice.
- The strategy of transitioning to temporary water as a production strategy presents risks to both the temporary and permanent water market.
- An investigation is required into the level of speculative investment by superannuation funds and non agriculture related enterprises.
- Water must be values and manages in the basin as a natural resource, not a commodity.

The Water Act 2007 and the Basin Plan 2012 must provide for the balanced weighting of economic, social and environmental impacts in all decisions made under those instruments.

Issues and opportunities

- Decision makers governments, their agencies and water managers need to more transparently demonstrate how economic, social and environmental considerations are taken into account in decision-making under the Act and the Basin Plan. This point is recognized by the independent expert panel into reporting on the review of the Water Act 2007 (Cth)
- An assessment is required on the impacts of the implementation of the Basin Plan on the water market and costs for remaining irrigators.
- Section 3 of The Water Act 2007 (the Act) has a requirement:
 (c) ...to promote the use and management of the Basin water resources in a way that optimises economic, social and environmental outcomes.

However

Section 21 of the Act provides the basis on which Basin Plan was developed.

Section 21 makes only 2 vague references to social (4) (b) and (4) (c) (v), and one to economic (4) (b) considerations. This is where the Act's framework for balanced social, economic and environmental consideration collapses.

- Independent, evidence based monitoring, evaluation and review (MER) is required to assess the effectiveness of achieving the social, economic and environmental objectives of the plan.
- Sustainable and resilient communities are imperative to maintaining a healthy working basin, the future of rural and regional Australia and our nation's food and fiber production.


The Federal Government's commitment to legislate to capbuybacks at 1,500 Gigalitres must be delivered, to provide security for impacted irrigators and to drive water efficiencies in other areas.

- The Government has noted it will only propose the legislation with bi-partisan support.
- The Government needs the support of Labor, and the cross bench Senators, to get any legislation through the Senate.
- Caution should be noted that the cap is an interim step only, a guarantee and is not the solution to providing security for irrigators.
- The "cap on buyback" is a maximum amount of water that may be purchased by direct tender from water owners.
- Buyback is the worst form of water recovery because it takes water out of the consumptive pool and reduces productive capacity.

 Buyback can create a 'Swiss cheese effect' in irrigation districts where operational costs remain fixed yet opportunity to recover those costs is negatively impacted through reduced delivery. Fees for remaining irrigators must go up to cover costs.

The MDBA must ensure that the 2750GL of environmental water to be recovered under the plan can be efficiently, effectively and safely delivered, and will achieve the intended outcomes.

- The Constraints Management Strategy has been criticised by many stakeholders as not reflective of the community consultations and concerns held about the ability to safely deliver larger volumes of water.
- Private property and business impacts including elevated risks of flooding caused by the proposed high level environmental flows must be assessed as part of the constraints management strategy.
- Investments in environmental efficiencies achieved through Sustainable Diversion
 Limits (SDL*) offset projects can help reduce the social and economic impacts on
 affected landholders and tourism. Such projects would allow 650GL of the Basin
 Plan's 2750GL recovery volumes to be achieved through creating efficiencies in
 river operations and environmental water use.
- Supply measures are works, river operations or rule changes that enable the use
 of less water but still achieve the Plan's environmental outcomes. Ensuring that
 these measures are devised and delivered in consultation with community to
 ensure efficiency and effectiveness will benefit the environment and reduce the
 social and economic impact of water recovery to achieve the Basin Plan's goal.
- The benefits and impacts of water used for environmental purposes must be identifiable and transparent and measured via agreed monitoring, evaluation and reporting mechanisms.


