#### 4. BUSINESS ARISING

Representatives from Broken Hill, Central Darling & Wentworth Councils attended the Inquiry into the rationale for, and impacts of, new dams and other water infrastructure in NSW. Cr Elstone attempted to bring up the 500GL cap, which they are now trying to extend to 1400GL, and was shut down as it wasn't within the terms of reference

Region 4 call on MDA to advocate to restore the 500GL cap for licencing and strongly opposes the current proposed legislation for floodplain harvesting.

This morning, the "Water Management (General) Amendment (Miscellaneous) Regulation 2021" was gazetted https://legislation.nsw.gov.au/view/pdf/asmade/sl-2021-91

As rain is forecast in the northern basin, it is particularly concerning to note the lack of consultation or publicity about these amendments.

**Mildura** – Cr Modica thanked everyone for his 31/2 years on the MDA and introduced Cr Reynolds is the new MDA representative for the Mildura Rural City Council.

Cr Modica's information

- 1. A recent private ruling made by the Australian Tax Office has revealed foreign residents are exempt from capital gains tax on water profits. It is quite possible therefore, that when Angus Taylor's Cayman Islands associates won their record \$80m windfall from selling water rights, they incurred no capital gains tax. The Tax Office ruling confirms what many farmers have known for years, that large, often foreign-owned, agribusinesses enjoy significant advantages over Australian farming families; not only because of their sheer size, and access to cheaper capital, but also tax.
- 2. What is being done to ensure the health of all rivers in the Murray Darling? The ongoing issue of Blue Green Alae seems even more pronounced this year.
- 3. How did the NSW Government introduce new laws last week allowing irrigators unlimited extraction during high flood levels? (See Cr MacAllisters information above) There was no debate in parliament and there seems to be little acknowledgment of the end of system flows required for healthy rivers systems in the country. The lower Darling and Menindee lakes are reliant on these end of system flows and hi volume floods to maintain any water. Victorian irrigators also benefit from higher percentage allocations from a connected Darling River.
- 4. Land and water, the big corporate buy-up

Australian farming is being increasingly corporatised:

- The ATO's report into foreign ownership of agricultural land shows that, as of June 2019, almost 14% of all agricultural land is held by foreigners.
- The Register of Foreign Ownership of Water Entitlements shows that as of 2018 10.4 percent, or 4035GL, of Australia's water entitlements have some degree of foreign ownership.
- Of foreign investors in Australian water entitlements, China and the US are the biggest, sitting at roughly 2% each, followed by UK investors at 1.1 percent.
- In 2019, there were 89,000 agricultural businesses across Australia, down 34 percent from 2010

# Balranald - Gavin

Balranald connectivity of Lake Yanga & the Murrumbidgee river update as follows:

Engaging with State Officers DPIE Water NSW, interdepartmental TOR for a scoping study. Thank you to the MDA for their advocacy.

NSW Water Strategy Murrumbidgee/Murray – timeframe feels like a tick and flick, unclear what outcomes we will get, they don't link with anything, not legislated and quite meaningless.

#### **Central Darling Shire Council**

With the recent decline in the Menindee Weir Pool Council have secured funding for water carting – Administrator & GM met with Minister Pavey re SDLAM project – project is dead in the water and told Environmental Minister that it is over and put it back to the Menindee people. Ensuring water flows into Menindee is critical and connectivity. Money which was allocated for the Menindee project, maybe this money could come to the Western Weirs project. Council also presented to the Inquiry into the rationale for, and impacts of, new dams and other water infrastructure in NSW. Council has Weirs at Tilpa & Wilcannia.

#### **Broken Hill**

Broken Hill were represented at the Inquiry into the rationale for, and impacts of, new dams and other water infrastructure in NSW.

Question to CEO of Murray Darling Association - Where are we up to with the RAMSAR listing of the Menindee Lakes?

CEO Response – It was passed as a resolution in 2018?? At the National Conference however we haven't been advocating.

Question to CEO of Murray Darling Association - Can we put this on the agenda for advocacy for the MDA? For MDA Region 4 & MDA National Conference the advocacy was a priority.

Recruitment is underway for these workshops with participants completing the MDA Academy Online Training prior to attending the face-to-Face workshops. The Online Academy covers five modules including: Leadership Theory; Water Literacy and Communicating with Impact.

The MDA will work in partnership with each of these towns to support the community, boost the local economy and encourage trade in small businesses with the remainder of the workshops to be rolled out across the rest of the year in the same format.

#### 5. Region 10A Engagement Strategy with Mayor Craig Davies.

This month myself and Mayor Davies, Narromine Council visited several councils within NSW to discuss the Macquarie-Castlereagh Over-recovery of water in the Macquarie-Castlereagh and Gwydir valleys impacting communities in the region, and to engage with councils to articulate the benefits of membership.
