#### 6. BUSINESS ARISING

#### Water Position Statement

Cr Kassebaum provided the following update:

- Expressions of Interest have gone out, received five applications.
- Applications were narrowed down to three.
- The three applicants were asked to give a presentation to the Working Group on their interpretation of the brief, what they had to offer and put the brief in two different price brackets (\$40,000 to \$50,000 and \$80,000 to \$90,000 price brackets). Price bracket will depend on the outcome of the Building Better Regions funding application.
- The Working Groups has decided on the preferred contractor.
- Letters will be sent to the other four applicants.

Emma discussed the reasons for choosing the preferred contractor.

#### Renmark Paringa Council – Water Stewardship

Myles Fauser, Environmental Officer, Renmark Paringa Council, spoke about Renmark Paringa Council's Water Stewardship plan.

- Identified everything they do with water.
- Understanding their water balance, total inflows versus total outflows to understand where they can improve on what they are doing.
- Developed the water stewardship plan on the basis that it would be of an international standard, Alliance Water Stewardship Standard (AWSS) (international water stewardship Standard).

Emma extended an invitation through the Chair to invited the Renmark Paringa Council to make a presentation to the Board of the Murray Darling Association and to encourage Region 5 to make a resolution that Region 5 promotes the adoption of water stewardship and the preparation of Water Stewardship Plans by Murray Darling Association member Council's

Emma congratulated Myles, Cr Peter Hunter and the Renmark Paringa Council on their Water Stewardship Plan.

Cr Raison asked what was the cost saving to the Renmark Paringa Council. Myles advised that cost savings cannot be quantified yet as they have only just developed and implemented the plan. The cost of implementation is probably around \$30,000, which covers auditing costs, staff time, development of the plan, formal processes and involvement of the AWSS.

Emma proposed the following a motion.

#### Moved Cr Raison Seconded Cr Hall

That:

- 1. Region 5 commends Renmark Paringa Council and Myles Fauser on the development of their Water Stewardship Plan and the work that has gone into it.
- 2. Region 5 recommends the process to the Board of the Murray Darling Association for their consideration.
- 3. Region 5 invite Renmark Paring Council to take a leadership role in encouraging this at a Basin scale.

Cr Raison thanked Myles and congratulated the Renmark Paringa Council on their Water Stewardship Plan.
