2.1 Mayor's welcome

5.2 Cr Greg Toll-MDA National President

Greg gave an insight into his Chairing the MDA and also wishing to see greater involvement of Council/Shires across the Basin. Greg was full of support for Emma and her new innovative way of trying to get the MDA into a more prominent association.

5.3 Chair Emma Bradbury-MDA-CEO

Presentation on the MDA, Emma gave a very detailed power point presentation of where the MDA is and where it is now seeking to head. It was very informative and was set out to encourage Local Government mainly to get on board. The MDA represents 127 Councils across the Basin, so the MDA has a powerful voice.

Geoff spoke about the need for water and echoed John Rohde comments that without water in the regions there will be no advancement or economic wellbeing. Geoff also spoke of the need to again try and meet on a more regular basis and he would do his best to attend or have a staff member present.

Geoff also mentioned his concern for the future due to the 'Millennium Drought' and he spoke about the importance of the MDA. Geoff mentioned that some City MP's do not engage enough, and emphasized the importance of continuous engagement.

He mentioned the necessity to get out and understand the issues and he identified the importance of the governance structure.
