#### 6.2 Murray River High flows discussions

- Cr John Forrester:
  - water levels were higher than expected;
  - people need to be patient.
  - Cr Margaret Howie:
    - Renmark Paringa were well prepared;
    - Closure of Bookpurnong Road closure impacted all Riverland residents;
    - Renmark Paringa infrastructure team have undertaken an audit;
    - With the river opening to boats, crews had to work to get boat ramps open;
    - Believes SA SES were overzealous to residents who were well above 56 level;
    - State media sensationalized stories.
- Cr Victoria Hammond:
  - Logistical issues for dairy farmers logistics;
  - Community access including ferries/high fuel costs;
  - Resources for pumping out low level water (SES/DEW);
  - Residents showing resilience;
  - Recovery now dealing with mould/rebuild and restoration
- Cr Andrew Kassebaum:
  - Main impact, Lake Bonney with the river 2.5m above lake;
  - Looking for locks to be reinstated in next couple of months.
