4. GUEST PRESENTATION

Anthony Wilson from the Commonwealth Environmental Water Office (CEWO) joined the meeting to provide an overview of the CEWO's local projects and community engagement activities.

The ensuing discussion covered topics such as cultural and recreational water allocations and water usage for environmental purposes.

Anthony advised the group that the CEWO can facilitate tours for Region 1 Councils to other areas of the Basin.

5. CURRENT ISSUES FROM REGION 1 COUNCILS

5.1 Albury

Cr Thurley advised that water quality (manganese levels) as a result of bushfires and floods has been an issue of late. Negotiations with MDBA took place to have oxygenated water released from the Hume Dam. There are no significant Murray Darling Basin Plan problems for Albury.

5.2 Federation

Cr Nicholls advised that there is a push for increases in recreational water in Corowa during peak summer tourist periods. Cr Nicholls will reach out to various members of the group to progress discussions on this matter.

6. CEO'S REPORT AND PRESENTATION

Mark Lamb took his report as read and noted the following highlights:

- MDA conducting a water forum in May in Mildura. Everyone encouraged to attend.
- National conference will be held in July this year due to NSW LG elections. The conference will be held in Tamworth with the CSIRO a notable sponsor.
- Continuing to drive membership across the Basin. Face to face meetings yielding stronger results than simple correspondence.
- MDA Board meeting held in Canberra last week which provided the opportunity for meetings with the Water Minister and Shadow Water Minister. Minutes from the Board meeting will be distributed to the group.

Mark also provided an update on advocacy efforts as well as a summary of recent discussions with the CSIRO.

The report was received and noted.

7. GENERAL BUSINESS

- Mr Lucas suggested that a future forum topic could be Snowy 3/Tumut 2.
- Cr Wortmann acknowledged Brad Ferris' input and attendance over the years and also thanked Albury City Council for ongoing support.
