1. From the Chief Executive Officer's desk

Now well into 2015, the preceding months and the year ahead remain as busy and dynamic as the last year has been!

2. Conference 2015

3. Projects

With Adrian's continuing absence (we hope to see him back to some part time work in mid-March) we are continuing to complete, and work on our project capacities.

Thanks must go to Owen Dunlop and Stacee Staunton-Latimer, project partners for their work in stepping up during Adrian's absence to launch that Creative Catchment Kids 2014 publications, and deliver the final NRM Education Program requirements in 2014.

4. Staff Matters

There have been some changes to staffing of the MDA in recent months.

Ms Linda Deans, Administration Assistant Albury office has left after almost a year of hard work and commitment to the goals and objectives of the association. Unfortunately, with work in the Albury office necessarily diminished, and the organization needing to restructure accordingly, the role of admin assistant was made redundant early in 2015. We thank Linda for all her hard work and wish her well in the future.

The process to recruit a Business Development Officer, Echuca based has commenced. This role will be crucial as the organization continues to grow and meet demand.

March Update -

Adrian Wells remains on medical leave, and has advised that owing to ongoing health issues, he is unlikely to return to work. We wish Adrian well with his continuing treatment.

Mr Stan Gibney has joined the team in the role of Finance Manager. Stan brings a wealth of experience, having worked internationally in finance management; internal and external audit; and governance processes across a range of industries. Most recently, Stan has spent 17 years in the role of Business Manager, Goulburn Broken Catchment Management Authority in Shepparton.

I am delighted to have Stan on board. Already a valued member of our small but growing team, Stan has a full worksheet for the year ahead as we continue to capture and consolidate the benefits of stronger financial management practices.

5. Murray Darling Foundation

Foundation Chairman Mr Brian Grogan OAM continues to work hard on Foundation matters.

Brian has made presentations at

- Region 3 Meeting in Swan Hill on November 27th to present the 2014 award for the MDF's Albert Heslop Memorial Travelling Bursary to Nathan Free of Tresco.
- Region 5 meeting in Renmark on December 1st at which he made a
 presentation promoting the travelling bursary which is sponsored by McArthur
 Management. Although in its sixth year, the bursary has received no
 applications from South Australia.
- The MDA Board Meeting in Swan Hill on February 6th, to ensure that the board remain informed and up to date on matters of interest to the foundation, and to maintain close working ties.

The Foundation Committee is due to meet and dates for the next meeting will be forwarded as soon as they are available.

March Update

Brian has announced his resignation from the chair of the committee. With Adrian no longer at work, and no meetings held since July last year, the current committee is no longer active.

Cr Oscar Aertssen, Chairman R2 has taken the position of Interim Committee Chair. He is currently taking expressions of interest for positions on the Foundation Committee, to be appointed by the board at the AGM.

6. Meetings - external

The Hon Bob Baldwin – Parliamentary Secretary to the Minister for the Environment

Monday 02 Feb 2015, The Chief Executive Officer, Emma Bradbury and National CrGreg Toll were invited to travel to Shepparton to meet with newly appointed Parliamentary Secretary to the Minister for the Environment The Hon Bon Baldwin MP, and with the incoming Chair of the Murray Darling Basin Authority. Mr Neil Andrew.

While in Shepparton we participated in a meeting of community stakeholders, convened by the Hon Sharman Stone MP, Member for Murray – and later attended a dinner for industry leaders within our sector.

At both meetings, Mr Andrews emphasized a commitment to continuing consultation with the MDA and the community more broadly; and Mr Baldwin was quite specific in his commitment to the implementation of the Basin Plan.

We were appreciative of the opportunity to meet with both men so early in their respective tenures, and emphasized the importance of ensuring that in implementing the plan, we are able to ensure a balance of environmental, social and economic benefits.

The Hon Craig Knowles farewell visit

Craig Knowles and Barry Hart, Outgoing Chairman and current board member respectively of the MDBA visited the Echuca office in January.

Mr Knowles was effusive in his praise and encouragement of the MDA's achievements

over the past 12 months. He noted the obvious hard work by the boards, and recognized the commitment to re-establishing the MDA's clear direction.

Both men commended the MDA on its new Echuca office and central presence in the basin, and Mr Knowles counselled that the journey to achieve our goals is 'a marathon...not a sprint".

Senator John Madigan

On Wednesday 4th Feb we traveled to Deniliquin to attend a meeting organized by the Southern Riverina Irrigators at which Senator John Madigan was the guest on a Regional Listening tour for messages for Canberra. We presented alongside RAMROC, and encouraged support from the crossbench in pursuit of the following objectives:

- a) That trade of environmental water needs to be simplified to allow greater reinvestment in infrastructure using money from the sale of environmental water, and to ensure access to cost effective water by our food producers
- b) A cap on how much the Commonwealth Environmental Water Holder (CEWH) can reacquire in pursuit of the Sustainable Diversion Limits (SDLs)
- c) That there needs to be a strengthening of focus in the implementation of the Basin Plan to provide equal weighting to delivering social and economic benefits to communities. Sustainability and environmental requires resilient communities, cost effect food production, healthy agriculture and strong regional economies in order to deliver environmental outcomes.

Definition: Unconventional Gas is found in highly compact rock or coal beds and requires a specific set of production techniques.

"That the Murray Darling Association:

- a. Will seek to have a moratorium placed on any further Unconventional Gas activity in any Basin that may be interconnected with the Murray Darling Basin on valuable arable land and until a solution is agreed upon of how to avoid salt mobilization.
- b. Will oppose the mining and exploration of Unconventional Gas, including the practice of

fracking, except where adequate guarantees based in science can demonstrate that there will be no adverse impact on the aquifers and ground water storage environment and on the quality of water contained in those aquifers and ground water storages.

- c. Will always be focused on the environment and local communities in pursuing this policy.
- d. Affirms that agricultural land is a vital and important asset and must be protected from any activities that compromises its productive capacities,
- e. Affirms that ground water is a vital and important asset and must be protected from any activity that might compromise its quality."

Purpose

To seek feedback and comment from member councils on the proposed governance model for the Murray Darling Association.

The proposed governance model seeks to enable

- a) a stable succession plan, capturing and retaining the knowledge and experience of our current board
- b) the development and implementation of a Corporate Plan to articulate the strategic direction of the organisation and provide clear direction into the future
- c) The delivery of stronger, skills based financial, corporate and compliance oversight of the Association
- d) Enhanced value to members through clarity of purpose and structured advocacy capacities.

The proposed governance model will enable the MDA to deliver strong regional representation, supported by an organisation demonstrating sound governance delivering financial accountability, clear strategic direction, corporate compliance and the capacity for growth and development.

Background

In 2012 the MDA identified a number of flaws in its governance, financial management and operational delivery.

In 2013 membership numbers fell, cash reserves diminished, key stakeholders were disengaging, of the Foundation was struggling to meet its obligations under the Rules.

In February 2014 the MDA resolved that the organisational management of the MDA required change, endorsing in-principal a proposed Change Management Plan.

In May 2014, the board employed a new CEO, who was tasked to review current operational practices and governance arrangements in order to deliver required change.

In September 2014, the board resolved as follows at its meeting 341

Item 6.4 Constitution

Constitution - Update and Compliance

As per earlier resolution of the board, the Constitution is currently under review for compliance and operability. MDA is in discussions with Russell Kennedy lawyers. Propose that the following time line and actions be considered

Date Action

14/10/2014 Notify membership at AGM of review. Call for input.

30/05/2015 Draft to board for approval

10/06/2015 Approved draft distributed to membership for feedback

30/07/2015 Board to consider recommendations

30/08/2015 Final draft circulated to membership for adoption at 2015 Conference

Motion: That the above action plan and time line be adopted.

Current Status

Actions already undertaken in 2014/15 by the current Board in support of the change management process have included:

- Commissioned a review of the constitution RK Lawyers working with MDA to develop the draft.
- Re-engaged the regions
- Identified a need to plan for orderly succession
- Articulated time limits they want, both individually and collectively, to serve on the board. Most
 current board members have identified that they each want to hand over to new, younger
 members in the coming 12 to 18 months, with a number already having foreshadowed their
 retirement.
- RK Lawyers have advised that it will be appropriate for the adoption of the proposed governance model that have board approval as a component of the development of the draft constitution.

At the board meeting held 01 May 2015, strong support was indicated for the above proposal, however it was requested that further opportunity be provided for board members to discuss the proposal with their regions, and member councils.

Proposal

It is proposed that the MDA adopts a governance structure that is consistent with the capacity to deliver on the core objectives of the Association, as follows:

- a) Board of Directors responsible for oversight of governance; compliance; risk management; strategic direction; resourcing and financial accountability; and succession planning.
- b) The Committee of Regional Chairs (CoRC) responsible for region meetings, advocacy, community engagement, basin related issues, representation etc.

The Board of Directors

- i) A Regional Chair representing Victoria
- ii) A Regional Chair representing NSW
- iii) A Regional Chair representing SA
- iv) A Regional Chair representing QLD
- v) A representative from the farming and irrigation sector
- vi) A representative from the environmental sector
- vii) A representative from the business and economic development sector
- viii) The Chair of the Foundation committee

The makeup of this board has several advantages

- a) A majority of board members are regional chairs, ensuring the strongest influence at board level is from the membership
- b) A position on the board will be represented by the Foundation, ensuring a stronger alignment there
- c) Three industry representative positions ensures a more diverse perspective
- d) A smaller board is more manageable and more affordable
- e) Targeted eligibility criteria will provide the opportunity for a competitive process and facilitate a strong mixture of skill level and perspective

The Committee of Regional Chairs (The CoRC)

The proposed CoRC will have the same composition and responsibilities as the current board has now regarding regional representation; managing the regions; providing guidance to the organisation; and setting the advocacy agenda.

The Chair of the CoRC will continue to represent issues at federal level on matters of policy and position, with the state chairs providing representation at state and regional level. It is envisaged that the CoRC will need to continue to meet at least 1-2 times a year, run the conference agenda etc.

The CoRC will not have responsibility for governance matters, reducing potential for conflict, and strengthening the capacities of the chairs to act solely in the interests of their local regions.

It will be the primary role of the CoRC in the first year under the new constitution to provide stability, guidance and knowledge to the new board, to ensure a strong and stable transition and to make sure that the knowledge and experience is handed on, not lost to the organisation.

If the MDA does not immediately begin planning for, and communicating with the membership on an effective transition management plan the organisation risks a catastrophic failure. It is not recommended that the association simply notify the membership and stakeholders when the current board are ready to leave. The Board must plan for an orderly transition, and bring the membership and stakeholders along on that journey.

The MDA will be more likely to attract quality candidates if they can see there is a strong and orderly transition plan, and that they will be supported through a structured process as they get up to speed. Without a transition plan, new recruits risk being overwhelmed, or set up to fail.

An effective succession plan will be an outstanding legacy of the current Board, and establish a solif foundation for the future of the association - whereas failure to plan may be a plan to fail.

Future Action

It is requested that the board member councils review the proposal, and provide comment and feedback. Your response is requested by Friday 15th May, to facilitate timely progress of the Constitution review.
