## 5. Motions for the Association's AGM; Mildura on 24 August 2012

### 1. OROC

**Motion:** Calling on the Government to look at raising weirs in our region to ensure

security of water.

#### 2. Mid-Western Council

The Murray Darling Association request to State or Federal Government to undertake a feasibility study for a new dam storage facility at Dixons Long Point.

**Motion:** To endorse motion to the AGM

All in favour: Carried

AW asked was it for a dam or bridge?

RH stated it was for dual reasons – helping with water problems and connections

### 3. Mid-Western Council

**Motion**: Seeking the association as to how to support one river to another prohibited. Treatment of the Macquarie and Cudgegong as two river systems.

GF asked why not all?

#### 4. Toorale Stations

**Motion:** That the MDA approach the Federal and NSW government environment ministers as well as Federal Minister Crean, requesting that they either sell or lease Toorale so that it can be returned to agricultural production and that conditions be placed on the sale or lease to maintain and protect the wetlands.

#### 6. Basin Plan discussion

RW commented - good economically and environmentally over the past couple of summer. Water sharing has delivered a good outcome.

KR read a quote from - Proposed Basin Plan Authority's view and consultation on the matters raised by the Murray-Darling Basin Ministerial Council – Volume 2 August 2012.

Discussion ensued – "communities require more water as they grow" "treatment to cater"

RN – writing to question quote.

AW spoke of the Murray Darling Basin and explained the effects on MDA Region 10 with an emphasis on the Warren area and outlining in particular the changes in demographics.

TG (Secretary - Shadow Minister for Natural Resource Management Katrina Hodgkinson) - Submission has been made for no more buybacks; through investments Concluded by stating "watch this space"

## 7. Mining & Agriculture – Land access discussion
